**RESOLUTION
NO. 1850-22**

At the regular council meeting held on November 3, 2022, the following resolution was introduced by Council Member **Reich**, seconded by Council Member **Melder**, and was unanimously passed.

WHEREAS, the Town of Woodworth has a need to adopt a set of rules that applies to public comments during the Town of Woodworth Council meetings; and,

WHEREAS, said rules are as follows:

- 1) **Anyone wishing to speak shall be given the opportunity to do so.**
- 2) **At regular town meetings, public comments will be received during Public Hearings and Points of Personal Privilege only. During Committee Meetings, public comments are allowed and encouraged at all times.**
- 3) **Persons wishing to speak may be required to approach the microphone, if so, requested by the mayor.**
- 4) **Persons wishing to speak may be required to state their name and address before being allowed to speak, is so requested by the mayor.**
- 5) **No person shall be allowed more than five (5) minutes to speak on any one subject, as determined by the mayor.**
- 6) **No person shall be allowed to make personal attacks on anyone else, nor use foul language. If, in the judgement of the mayor, such action occurs., the speaker will be prohibited from continuing.**
- 7) **Speakers may make comments but are not entitled to answers from the Mayor or Council. Speakers will not be allowed to engage in exchanges with anyone else in the audience.**
- 8) **The mayor shall decide anything not covered above on a case-by-case basis. To maintain order, the mayor shall have sole discretion in any matter not covered above.**

NOW THEREFORE BE IT RESOLVED, the Mayor is hereby authorized to place the above rules pertaining to public comments at council meetings into effect.

This resolution shall become effective immediately upon its passage.


