

MUNICIPAL MINUTES

The Mayor and Council Members met in regular session on **March 6, 2025**, at 4:00 p.m. with Mayor Butler presiding and the following present:

Mayor Butler called the meeting to order further stating there was a quorum. Police Chief James P. Gonzales led in the invocation and Fire Chief Paul Delanoix led in the pledge of allegiance.

New business:

Mr. Thomas C. David, Jr., reported on the town's current projects. A forty-five-day for punch list items and clear lien certificate will be accepted while the fire station is near the final stage of completion. The FEMA application is being submitted for flood prevention. The Brookwood subdivision is in the close out phase (fence and cleanup work). We are waiting on the DRA money to pay the contractors. PHMSA is 90% complete PanAmerican is preparing drawings, and the environmental access report. Water sector grant (inclusion of Tall Timbers, Assembly of God Campgrounds) has been approved allocating \$3.2 million dollars; the paperwork is being prepared.

Amendments to Ord. No. 34-94, Introduction to Governing Authority, was introduced by Council Member Reich, and is proposed for adoption at the next regular council meeting of April 3, 2025 at 4:00 p.m., at the Woodworth Municipal Building.

Res. No. 1929-25, pertaining to **the Condemnation Decision** (9178 Hwy. 165 South), was made by Council Member **Aymond**, seconded by Council Member **Reich**, thus passing by unanimous vote.

Res. No. 1930-25, pertaining to **Fire Station Addition Substantial Completion** was made by Council Member **Reich**, seconded by Council Member **Kitchen**, thus passing by unanimous vote.

Res. No. 1931-25, pertaining to **Water Pollution Prevention Environmental Audit**, was made by Council Member **Aymond**, seconded by Council Member **Harrington**, thus passing by unanimous vote.

The Mayor, Fire Chief and Chief of Police all gave monthly reports.

Upon motion by Council Member **Aymond**, seconded by Council Member **Reich**, the town meeting was adjourned by unanimous vote.
